**Assumption of the Risk and Waiver of Liability Relating to  
Coronavirus/COVID-19 & Personal Injury**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments as well as federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Encore Band Camp, LLC along with Gordon State College has put in place preventative measures to reduce the spread of COVID-19; however, Encore Band Camp cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending an overnight camp could increase your child(ren)'s risk of contracting COVID-19.

By electronically agreeing to this agreement, this serves as my electronic signature. I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participating and attending Encore Band Camp on the campus of Gordon State College and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Encore Band Camp. On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless Encore Band Camp, LLC, along with its owners and staff, of and from all claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of Encore Band Camp or its owners and staff, whether a COVID-19 infection occurs before, during, or after participation in Encore Band Camp. I also release Encore Band Camp from liability in the event of injury.
